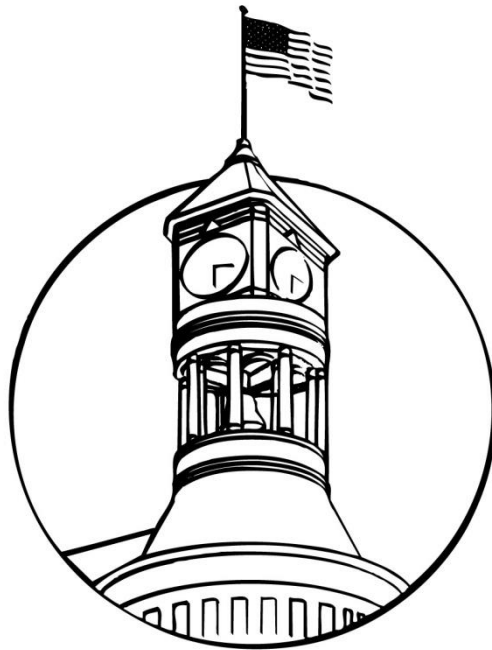

1. Tree and Stump Removal Combined. Pricing based upon diameter size:

  - 31" to 40" \$ \_\_\_\_\_ per inch diameter
  - Above 41" \$ \_\_\_\_\_ per inch diameter
  
2. Stump Removal Only (diameter 3" above ground) \$ \_\_\_\_\_ per inch diameter
  
3. Tree Trim on an individual scattered basis, including  
Deadwood removal (DBH) \$ \_\_\_\_\_ per inch diameter
